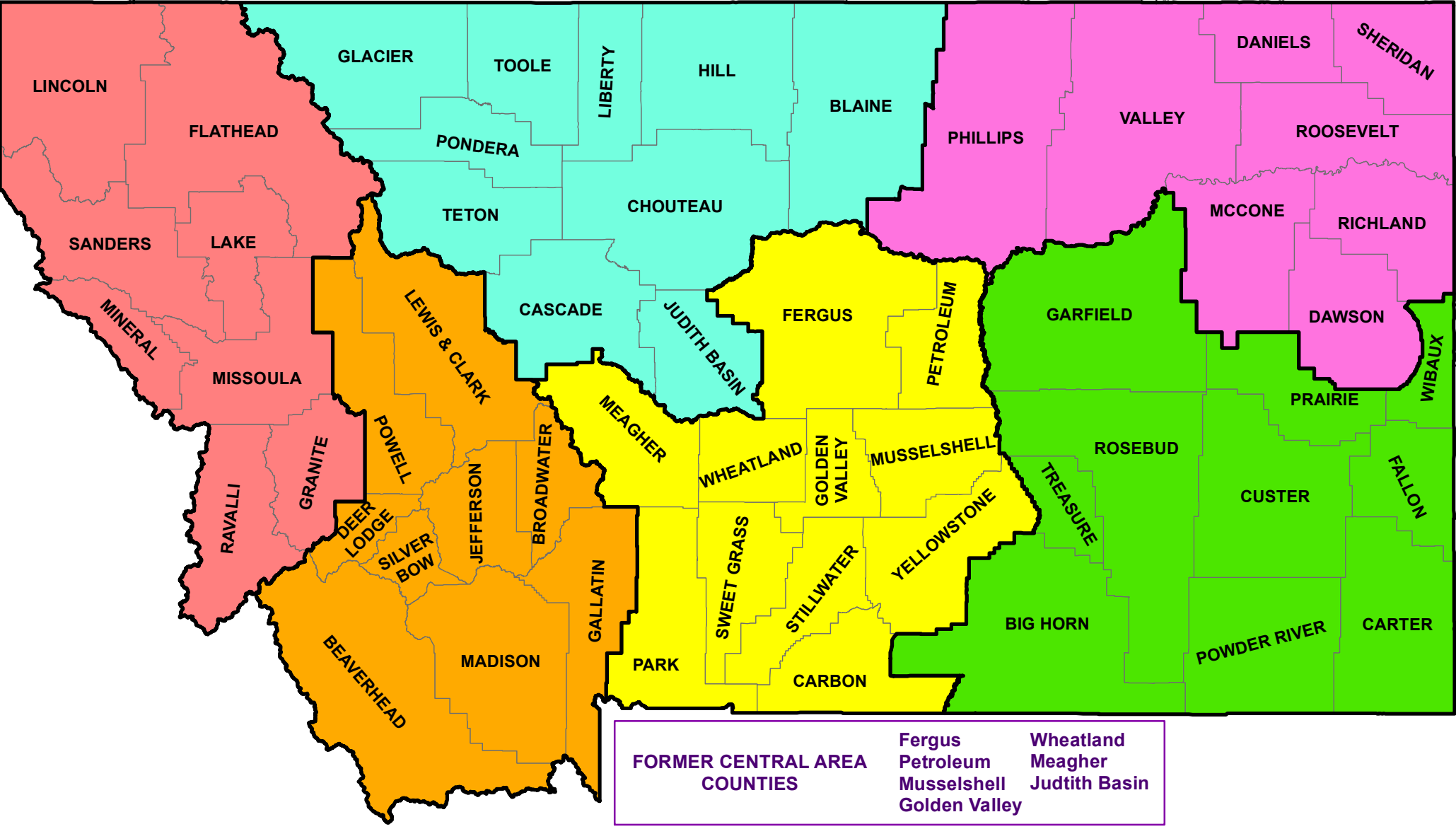


MWCA 2022 Ballot Board Positions

President	2023 – 2024 (2 year term)	Experience on the MWCA Board Member is a plus
Vice – President	2023 (1 year term)	Experience on the MWCA Board is a plus Will chair the Annual Conference Planning Work Group Will NOT automatically roll into the President position First 2-year term will be elected in the 2023 election for 2024-2025
Treasurer	2023 – 2024 (2-year term)	Will chair the Finance Committee and over sees MWCA Finances
Southwestern Area Representative	2023 – 2024 (2-year term)	Represents the MWCA members of Powell Jefferson, Madison, Gallatin, Broadwater, Beaverhead, Silver Bow, Deer Lodge and Lewis & Clark counties on the MWCA Board
Southeastern Area Representative	2023 – 2024 (2-year term)	Represents the MWCA members of Garfield, Prairie, Fallon, Rosebud, Treasure, Custer, Powder River, Carter, Wibaux, and Big Horn counties on the MWCA Board.
Western Area Representative	2023 (1 year term)	This is a 1-year term to complete the term that the elected representative resigned from in 2022. Represents the MWCA members of Lincoln, Flathead, Sanders, Lake, Mineral, Missoula, Ravalli, and Granite counties on the MWCA Board.
Triangle Area Representative	2023 – 2024 (2-year term)	Represents the MWCA members of Glacier, Toole, Liberty, Hill, Teton, Blaine, Pondera, Chouteau, Cascade, Teton, and Judith Basin counties on the MWCA Board.
Northeastern Area Representative	2023 (1 year term)	This 1 year term is to fill a position that was appointed in 2022. Represents the MWCA members of Phillips, Valley, Daniels, Sheridan, Roosevelt, McCone, Richland, and Dawson counties on the MWCA Board.
Director-at-Large (1)	2023 – 2024 (2-year term)	The intent of this position is to bring in skills and perspectives from outside the traditional MWCA Board of Directors track.
Director-at-Large (2)	2023 – 2024 (2-year term)	The intent of this position is to bring in skills and perspectives from outside the traditional MWCA Board of Directors track.

Director-at-Large (3)	2023 (1 year term)	The intent of this position is to bring in skills and perspectives from outside the traditional MWCA Board of Directors track.
